Minnesota Valley National Wildlife Refuge Trust, Inc. (Trust) and Minnesota Valley National Wildlife Refuge and Wetland Management District (Refuge) have partnered together to provide paid, developmental opportunities for individuals who are committed to diversity, equity and inclusion in the field of conservation.

We are hiring <u>two full-time</u>, <u>two-year</u> Conservation Biology Apprentices to join our Biology Department to work alongside Us Fish and Wildlife Service (USFWS) professionals and learn how to manage, restore, and protect vital natural resources.

#### As a Biology Apprentice you will:

- **Conduct** plant, invertebrate and bird surveys in diverse habitats across the Twin Cities Metro Area and South Central Minnesota
- Manage invasive species (will include herbicide application).
- Support public education and outreach programs alongside Refuge staff and volunteers
- Assist the refuge on various habitat restoration projects and administration processes
- **Explore** various career paths, gain new skills and network with Refuge and Trust staff, local organizations, and existing partners within the field of natural resource management.

- Post-secondary 2 or 4-year degree
- Valid driver's license

#### **Preferred Qualifications:**

- Strong interest in one or more of the following: community outreach, habitat and wildlife management, biology, ecology or entomology
- Excellent written and verbal communication
- Ability to work independently and as part of a team, detail-oriented and organized, ability to follow oral and written direction
- Experience with or desire to learn Midwest plant and animal identification
- Experience with or desire to learn GPS and GIS technologies, canoes, ATVs, farm equipment, and mowers (please note experiences on resume)

This position includes working in both indoor and outdoor settings. Outdoor working conditions may include the following: being outdoors for extended periods of time in all weather conditions, exposure to biting/stinging insects and ticks, exposure to poisonous plants, and hiking over uneven terrain through tall vegetation while carrying heavy equipment weighing up to 45 pounds. **On the Job Training:** Apprentices will gain marketable field skills and career networking opportunities to further their career in natural resources. Training and experience will include conducting wildlife and plant surveys, designing and managing habitat restorations, building skills with ArcGIS Field Maps and navigation, pesticide application, heavy equipment operation and much more. Apprentices will be mentored by USFWS professionals and network with Trust employees and Refuge staff, interns and volunteers and community partners.

**Special Hiring Authority:** Apprentices may be eligible to receive a Department of the Interior Public Lands Corps non-competitive hiring authority certificate upon completion of their term of service. More information provided upon request
